DISCUSSION REGARDING MEDICAL INSURANCE RENEWAL

### RECOMMENDATION

It is recommended that the Personnel and Contract Committee review the 2025 proposed rate increase from Kaiser Permanente for medical and dental coverage and provide staff with direction on selecting a plan that continues to offer full time employees excellent coverage.

### **BACKGROUND**

Rossmoor Community Services District currently provides medical and dental benefits to its full time employees through Kaiser Permanente. The renewal rate for the current Kaiser plan is scheduled to increase by 7.08% effective January 1, 2025 which would increase the monthly premium from \$8111.96 to \$8744.96

RCSD staff has connected with ADP brokerage services who will be presenting coverage options to the Personnel and Contract Administration Committee that most closely match what is currently offered to employees. The goal is to present the recommendation of this committee to the RCSD Board of Directors at their regular meeting on December 10, 2024.
